

- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college/Institute.
- 8) The college shall not admit the students for the Academic Year **2024-25** after the cut-off date prescribed by the CCIM /(NCISM), New Delhi.
